#### SECTION III: HAZARDOUS IDENTIFICATION

**Route of Entry:** Eye, skin contact, ingestion.  
**Potential Health Effects:**  
**Eye Contact:** May cause moderate irritation to eyes.  
**Skin Contact:** May cause irritation. Slightly hazardous in case of skin contact (permeator).

#### SECTION IV: FIRST AID MEASURES
